2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

DANGER. CORROSIVE. CAUSES SKIN AND EYE BURNS. HARMFUL OR FATAL IF SWALLOWED.

Principle routes of exposure: Eye contact. Skin contact. Inhalation.

Eye contact: Corrosive. Causes permanent eye damage, including blindness.

4. FIRST AID MEASURES
